

**Resolution for Adoption by the Board of Education – Arts Academy in the Woods  
2017-2018 General Fund Budget (Amended)**

Resolved, that this resolution shall be the general appropriations of Arts Academy in the Woods for the 2017-2018 fiscal year; a resolution to make appropriations; to provide for the expenditure of the appropriations; and to provide for the disposition of all revenue received by the Arts Academy in the Woods.

Be it further resolved, that the total revenues and unappropriated fund balance estimated to be available for appropriation in the General Fund of the school district for fiscal year 2017-2018 to be used for operating purposes is as follows:

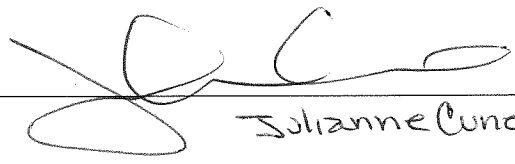
